### TERMS

BEFORE your pet's arrival, Mill Creek Kennels must receive CURRENT vaccination records. Your Vet may fax this information to 731-987-7787 (CALL BEFORE FAXING), or email a scanned copy to m-c-k@hughes.net. The required vaccinations for dogs are: Rabies and DHLPP (Current in the last year); Bordetella (current in last 6 months); and Fecal Exam (Current in the last year). We don't accept "owner administered" vaccines.

Mill Creek Kennels agree to exercise due and reasonable care to keep the kennel premises sanitary and properly enclosed. The animal is to be fed properly and regularly, and to be housed in clean, safe quarters. Each pet owner is encouraged to provide their own food to keep the pet's diet consistent. If, during the pets stay, the provided food runs out, we reserve the right to substitute the kennels standard high quality feed. Exceptional food preparations or additional feedings are subject to an additional charge of \$2.00. Medication administration is limited to oral and topical application at a fee of \$1.00 per dose.

**Mill Creek Kennels cannot give injections.** Pet's requiring specialized care will be considered on a case by case basis and may be subject to a \$5.00 daily fee. All animals are boarded, or otherwise handled or cared for by Mill Creek Kennels without liability on Kennel's part for loss or damage from disease, death, running away, theft, fire, injury to persons, other animals or property by said animal, or other unavoidable causes, due diligence and care having been provided. It is expressly agreed by Owner that Mill Creek Kennels' liability shall in no event exceed the current chattel value of a pet of the same species, or \$250.00 per pet boarded, whichever is less.

No animal is to be taken off the premises except by the consent of the owner. If the animal becomes seriously ill, the owner shall be notified at once at the phone number designated for emergencies. If the owner is unavailable and/or the state of the animal's health reasonably demands quick action, Mill Creek Kennels are hereby authorized to call a Veterinarian, as designated above, or to call a veterinarian of the Kennel's choice or take the animal to said veterinarian in either case, or administer medicine or give other advisable attention, within the Kennel's discretion and judgment, and such expenses, being reasonable in amount, shall be paid promptly by the owner of the animal.

If any charges for boarding, medicine, veterinary services, or other services rendered are not paid within ten days after they are due, or if the animal is not called for within ten days after time for return of the animal, the animal will be sold or placed within ten days after this period by the Kennel publically, privately, or otherwise for the best price available. Notice in writing of such intended sale or placement shall be mailed by Certified Mail, Return Receipt Requested to the owner of the animal at the address given hereon not less than fifteen days before such intended sale or placement, and no further notice shall be deemed necessary. Any excess amount over charges will be given to the owner, any deficiency is to be paid by the owner. If collection agency charges or if other expenses accrue in the collection of any outstanding debt, such expenses will be paid by the animal owner.

The owner represents that he/she is the legal owner of the animal, that title to the animal is not mortgaged in any way, and that the animal has not been exposed to distemper or rabies within the last thirty days, and that the required annual license has been obtained. It is understood and agreed that all unpaid charges shall become a lien on the animal until they are paid in full. No other representations, expressed or implied, are made, unless set forth in this agreement, and this agreement shall constitute the parties' entire understanding.
